I can confirm the steps are not permanent and are just on the plan for visual purposes.

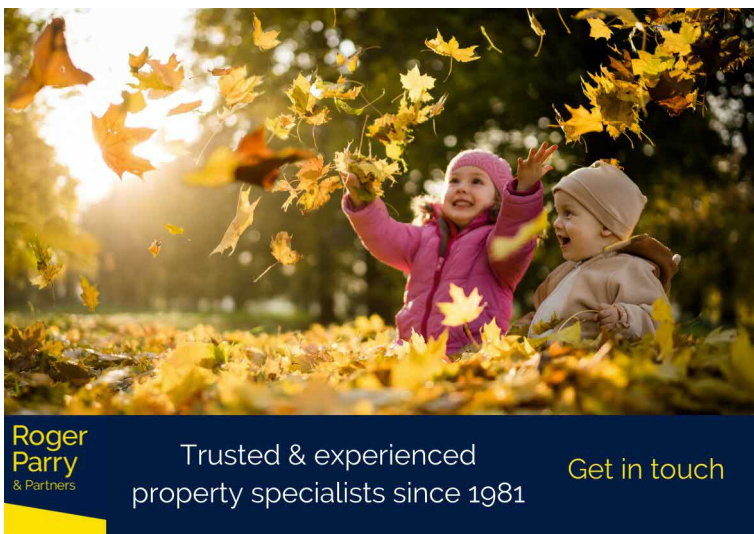
