T9:-mature ash tree adjacent to the garage and driveway, all over reduction back to the previous points, approximately 3meters.

T10:- mature ash tree in the garden area, stem bifurcates at 1-2.5 meters with poor attachment, no natural bracing. Dieback at extremities of the crown, suspect ash dieback infection, deadwood and stubs throughout the crown, overall condition is poor with no low growth points for reduction, fell to ground level

T11:-English oak, overall condition and vitality are good.reduce back to previous points by approximately 3meters all round to prevent failure of branch attachments. Would recommend repeating this every 5 years
