Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1and T2 are silver birch affected by the Birch Polypore. We have been advised that these trees should be removed as they are diseased and are at risk of falling. These two trees sit close to our boundary but are also in close proximity to The Spinney a neighbour where there are children. As numerous large branches have already broken off there is an iminent to life and property.

T3 is an Oak tree. We would like to reduce the crown by 2-3 metres and remove deadwood.. This tree is relatively healthy but does impact on producing shade and a risk to grandchildren that play regularly in our garden from falling deadwood.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
