We have recently noticed that the Magnolia tree in the front garden has a large amount of wet soft rot lower down in trunk. This is where tree splits into 2 large branches to form the branch/leaf/flowers. Having discussed the issue with the tree surgeon we would like to remove the more rotten branched off half in the hope of slowing down the rot on the other part. The tree is approximately 15-20 feet high and just over 6 feet from the path. We would also like to trim the tree that is left by approx 6 feet.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
