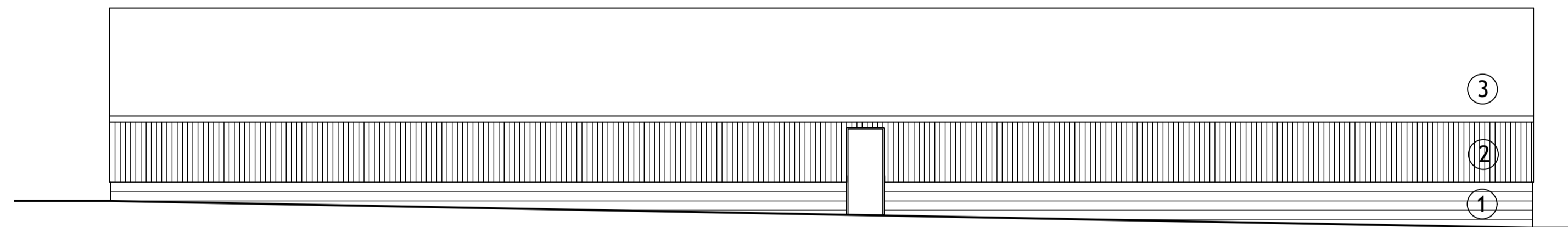

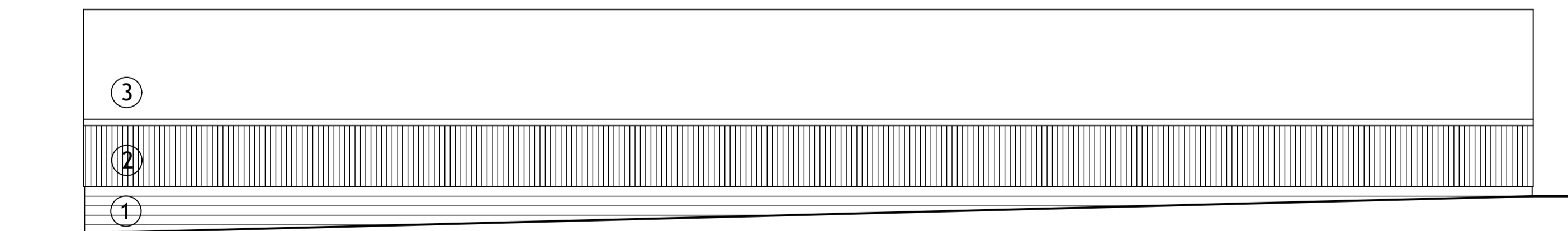

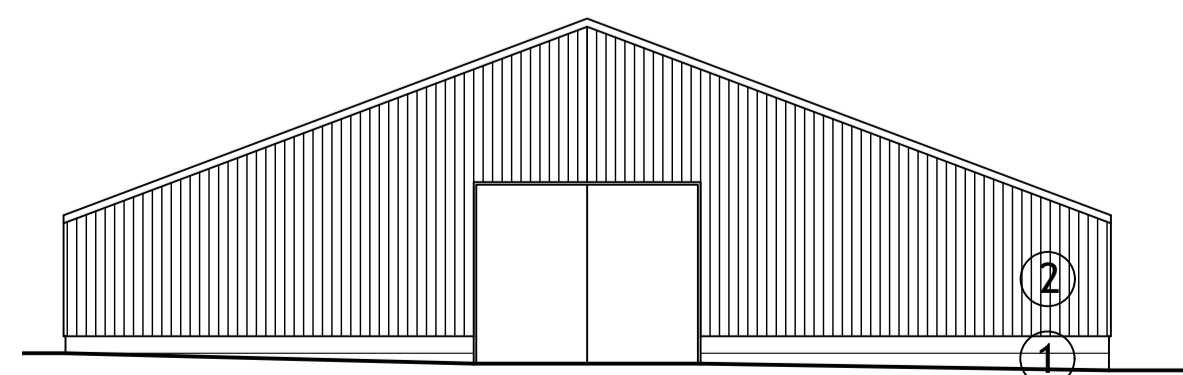
EXISTING SITE PLAN 1:200



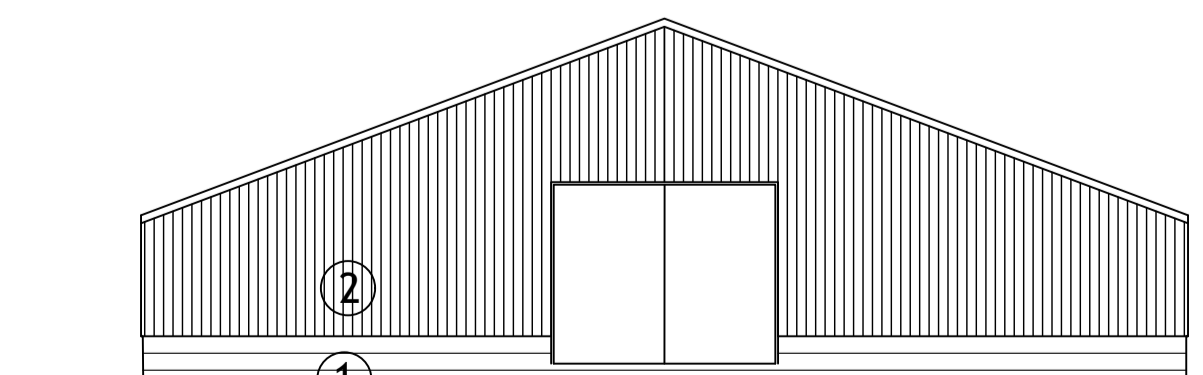
EXISTING ELEVATION "A" 1:100



EXISTING ELEVATION "B" 1:100



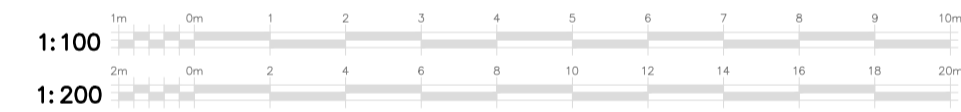
EXISTING ELEVATION "C" 1:100
