PROPOSED WORK TO TREES IN A CONSERVATION AREA

SECTION 211 NOTICE UNDER TOWN & COUNTRY PLANNING ACT 1990

CONSERVATION AREA: The Swindon Village Conservation Area

WORK PROPOSED: T1: Silver Birch, Crown reduction: removal of regrowth. T3: Cherry, Crown reduction: removal of regrowth. T5: Cherry, Crown reduction, removal of all regrowth, back to previous reduction points. T6: Cherry, Crown reduction, removal of all regrowth, back to previous reduction points. T7: Hazel, Crown reduction, removal of all regrowth, back to previous reduction points
T8: Sycamore, Crown reduction, removal of all regrowth, back to previous reduction points. T9: Cherry, Crown reduction, removal of all regrowth, back to previous reduction points. T10: Hazel, Reduce by 1m and shape. T11: Cherry, Specification to include removal of all regrowth, back to previous reduction points. T12: Hazel, Reduce by 1m and shape. T13: Ash, Crown reduction, removal of all regrowth, back to previous reduction points. T15: Cherry, Crown reduction, removal of all regrowth, back to previous reduction points

I refer to your notice received on 24th November 2022 to undertake work to trees as described above.

A decision has been made under authority delegated by the council, not to place a Tree Preservation Order on the tree(s) and have **NO OBJECTIONS** to the proposed work as set out in the notice.

All works should be carried out within two years of the date of this letter. A further notice will be required after the expiry date of the two year period.

Informatives:

Anyone who kills, injures or disturbs bats, obstructs access to bat roosts or damages or disturbs bat roosts, even when unoccupied by bats, is guilty of an offence under the Wildlife and Countryside Act 1981, the Countryside Rights of Way Act 2000 and the Conservation (Natural Habitats & Co.) Regulations 1994. Prior to commencing work you should ensure that no bats or bat roosts would be affected in line with BS 8596 (2015) Surveying for Bats in Trees and Woodlands.

Anyone who takes, damages or destroys the nests of any wild birds whilst that nest is in use or being built is guilty of an offence under the Wildlife and Countryside Act 1981. Prior to commencing work you should ensure that no nesting birds will be affected.

You should comply with BS3998:2010 "Recommendations for tree works" a copy of which can be inspected at this office and you are advised that the work should be undertaken by a suitably qualified, experienced and insured tree contractor.
