Provision of leisure and community facilities.

The original play equipment at the Cricket was put in over 40 years ago. Its construction is mainly wood (apart from fixings, swing sets, actual slide etc.). Various repairs have been done over the years to the point that the wood in the big swings contains pieces from 12 years ago, 8 years ago and last year. This is probably true for the other pieces of equipment, which have not been condemned and removed. The picnic bench was replaced about 12 years ago and the little train was added about 10 years ago. The ambitious Play Area project will deliver an inclusive and freely accessible facility for users who live in Haughley Green, the surrounding area and for visitors. The community supports the proposed upgrade the play area, which is designed to meet the play needs of current and future generations of children, be they able-bodied or disabled.

The upgraded facility will provide a high-quality outdoor play facility with currently recommended safety features. The project will provide an inclusive play area, where children can interact with each other, play, and learn, whilst at the same time having have fun in a well-designed, sensory-rich environment. The facility will address all levels of ability and encourage children's physical, social, and emotional development through the provision of interesting and varied play experiences.
