T1- Sycamore, Large cavity at 5m which is an old pruning wound that hasnt healed over (visuable from ground level). Probe shows the cavity is around 1m deep. Fell due to safety.

T2 - Sycamore, Growing close tot he property. Tall spindley tree. Fell. Felling would also give more daylight to the beech trees on the wood floor. to develop.

T3 - Sycamore, Growing close tot he property. Tall spindley tree. Fell. Felling would also give more daylight to the beech trees on the wood floor. to develop.

T4 - Ash , Prune to give 3m clearance from the neighbors property.

T5 - Sorbus, tree has failed and resting in the adjacent holly. Fell

T6 - Holly, out grown the garden, currently has a sorbus resting in it. Fell

T7 - Sycamore Radially reduce the sound spread from 6m to 4m this will reduce the end weighted branches to the south and minimize failures.

T8 - Sycamore Radially reduce the sound spread from 6m to 4m this will reduce the end weighted branches to the south and minimize failures.
