"The proposal is to put the spoil bank back into the area that it was originally dug from in 1990, when saltmarsh (priority habitat) was lost to the creation of a birdwatching lagoon. This will restore a natural landscape feature, a positive step as identified in the ELDC Local Plan Report (2016) Stage 1 HRA, Gibraltar Point Conservation Objectives section 3.4.6.
The bank has never had any flood defence recognition and LWT have a notification from the Environment Agency to say no flood permit is required for the proposed works.
The removal of the bank has also passed approval through the Regional Flood and Coastal Committee and Lincolnshire County Council."
