Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

A single, mature beech tree with trunk in the garden of Claremont House, Burwardsley Road, Tattenhall owned by my next door neighbour, [REDACTED]. Whilst the trunk of the tree is located in my neighbour's garden, approximately 40% of the tree's branches and foliage overhang my front garden. The tree is in full leaf and, to my untrained eye, is healthy.

I believe that a successful planning application (18/02252/TPO) was submitted in June 2018 for a "crown lift" to be performed on the tree in order to provide clearance for road traffic and to provide improved natural light to the then owners of my property (which was at that time called "The Coppins"). Following approval of the application, the work was carried out. In a little over 4 years however, the tree has further matured to the extent that it is again overhanging the road and natural light to the front of my house has again become severely compromised.

Given the size, age and speed of growth of the tree, the reason that I believe that the above "pruning exercise" has proven to be undermined within such a short space of time is that the previous application requested that the crown lift should only provide clearance of between 12 and 15 feet from ground level. I believe that the character and appearance of the tree would have still been retained had the the clearance been nearer 30 feet and it is to this level that I apply for a similar crown lift to be undertaken. Even at this level, given the growth pattern of the tree, this expensive exercise would still, by my estimation, need to be repeated every 6-7 years (rather than the current 4).

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
