Both trees are cherry trees and believed to be between 40 and 50 years old. Given to understand that such trees usually live around 40 years old. A tree surgeon has stated that one of them is dead and that the other one is in a poor state of health. We only became owners of this house in july and we have been told that large branches have previously broken off the trees and damaged the adjacent wall. We would like permission to chop down both trees due one being dead and the other in poor health. Its possible that if they are not removed or extensive works carried out that they pose a danger to nearby properties.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
