Planning permission has been granted (CA/21/02777) for a single storey dwelling at Marleywood Yard. The block plan for the building and parking is attached (Marleywood Yard Block Plan 22nd April 2022). Also attached is a block plan for the whole site (Marleywood Yard Block Plan Whole Site)

The remainder of the site (Marleywood Yard Barn Block Plan)has been classified as Commercial and is used as vehicle and equipment storage for a tree surgery and forestry enterprise.

Currently these buildings are constructed of wood feather boarding and and not attractive and not in keeping with the new development of the bungalow. This application is a request to demolish these old facilities (115 sq metres) and rebuild a barn/garage (113 sq metres) with the same building materials as the new single storey dwelling.

The new building would be at 90 degrees to the existing building and would provide parking/storage for 3-4 vehicles and equipment This would improve the overall character and quality of the site
