T1 sycamore remove to ground level as

Showing signs of decline indicated by sparse canopy most likely due to a heavy pollard in the past and had large rot pocket at base of tree possible caused by development of property in the past - not leaving the recommended third of trunk diameter of solid timber so leaving an unstable tree . The tree is situated very close to the property so poses a very real risk of falling and damaging said property .

Please see attached independent report from an arboriculture consultant backing up these findings .

Tree will be replaced with native species up to home owner choice and situated in a more appropriate place on the property

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
