Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T7 - based on previous records possibly beech tree (leaves are not oak) next to boundary fence of 28 Tynedale Gardens - main trunk within boundary of 28 Tynedale Gardens. Request to remove two large branches (originally thought to be one) seen in photos A to C,E and G, together with mass of light branches, ivy and overgrowth and sucker growth visible in photographs linked to that large branch, up to the now broken fence on my garden side but not beyond the fence. Growth is approx 2 to 3 metres high growing horizontally about 4 metres across garden. Reason for request is to prevent further damage to boundary fence and to allow safe access to this part of my garden. I also feel this growth detracts from protected area and the tree itself, as indicated on photographs.

T4 - oak tree within my garden. Request is the removal of the large dead branch on T4, on photograph D, which is about 6 metres up. I believe this may be storm damage. My request to remove this is to prevent risk of this falling down directly into the garden and causing damage or injury. I believe not removing this would be negligent. If identified I also request the removal of any dangerous deadwood on T5 and T6, up to a height of 6 metres.

T2 - oak tree - main trunk within boundary of 28 Tynedale Gardens - I request permission to remove similar dead branches and low hanging light branches to a height of 6 metres on T2 - an oak tree, up to but not beyond the boundary fence on my side. Photograph E shows main overhanging light branch about 3 metres - it is difficult to identify the individual thin branches. The reason is to remove risk of injury and damage, and to allow greater access to this part of my garden.

Photo F shows overall picture of branches and overgrowth that have occurred after 1971.

I have also attached photos of historic maintenance request and council decision document.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - sketch in buildings, including adjoining properties

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
