Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Rowan -T2- reduce to 1.5 metres below the overhead cables -to keep the tree out of the cables.

Strawberry tree -T5- fell because this tree is pressing on the retaining wall next to it and has cracked the wall.

Monterey Cypress -T10- fell because this large non native tree is taking a great deal of light and space from an area of garden which The Blue House wish to renovate and where it is planned to make a garden walk for residents.

Poplar -T11- fell because this tree has very poor form and a very significant lean. It would be unlikely to survive without the shelter of Tree 10. Poplars -T12, T13 and T14)- reduce by 10 metres height and 4 metres spread. This is because these large trees, of a wood type known to be weak, lean towards a public car park and have now reached full size. It is important to reduce the risk these trees pose as they start to decline.

Poplar -T 11- fell. This small tree is dead.

Poplars -T23 and T26- reduce by 10 metres height and 4 metres spread. These two trees have stems which lean significantly across the river and threaten the road on the far side.

Goat Willow -T33- fell because this tree is moribund. Replace with an Alder.

Silver Birch -T36- reduce by 4 metres height and 1 metre spread all round. This tree has a large cavity at the base and could fail in high wind. By reducing the leverage on its weak base, we will reduce the risk of its failing.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
