We are applying to remove the decaying Horse Chestnut T4 and decaying in G1 as recommended by Tree officer on recent visit. This will allow the planting of younger trees in their place to hopefully grow to the tree the Horse chestnut once was back in it prime before the decaying of the body of it. This was first documented in the January 2017 Tree Report by Ian Monger highlighting to significant decay discovered in the 2017 report.

The removal of T4 Horse Chestnut and G1 Tree in poor condition decade and growing on rubbly rock face, as recommended by Tree officer on recent visit.

  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
