Work on a Sycamore tree in the front of the property. Lower lateral limbs overhanging The Street, recommend to reduce top weight by 1.5 metres, reduce limbs around power lines Risk of falling onto street and onto power lines bringing them down.

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
