I am seeking permission to remove one lilac tree and approximately 23 m of mixed Berberis type hedge from the boundary of the property with Broomsthorpe Road. Photographs and a sketch are attached.			

The reason for the request is that honey fungus is present and has killed both the tree and the hedge. We have previously lost a Willow tree in the same location to the fungus. We propose replacing the hedge with a woven willow fence of just under 1m in height, but we understand the fence does not require planning consent whereas the removal of the tree and hedge does, hence the application.

This matter has been discussed during a telephone conversation with Mr Richard Fisher who suggested that to plant a new hedge would more than likely result in the honey fungus attacking the new plants.

The tree and hedge are situated on the boundary of the property with Broomsthorpe Road. The works involved are the removal of the lilac tree and the mixed Berberis hedge.
