I would like to fell tree T5 a Maple tree which is 15.8meters tall and is only 9.6m from the house, this tree has some areas of dysfunctional and delaminated bark. This tree has very little if any amenity value as it's situated in the back garden. We feel the back garden is so crowded with large trees, thinning them out will allow the remaining trees to flourish.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
