All trees situated to right of Rudham House, on the drive way and alongside Broomsthorpe road.

Marked A on sketch - 4 large Beech trees - request to tidy canopy and reduce by 25%, one is close to the road and unsafe. Marked B on sketch - 1 large oak next to beech across the drive - reduce over extended lateral limb growing towards lawn area to suitable growth point. Also make safe main trunk with large break and woodpecker hole in.

Marked C on sketch - Remove large overgrown conifer hedge line adjacent to Oak.

Marked D on sketch - 1 large Ash - adjacent to conifers and Oak - reduce width and height by 25% to maintain safety of tree structure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
