This follows on from 21/00066/TREECA in which permission was given for a row of Leylandii previously topped to be reduced to a height of ~6 feet. This has resulted in a row of essentially bare trunks, which will not grow back. We would now like to reduce these to ground level and plant young deciduous trees, for example: rowan, crab apple, elder, hazel so as to produce screening against a fence. The proposed tree species will have habitat value and increase biodiversity. We would also encourage the growth of plants, such as teasel and sun flowers that would also provide food for birds and pollinating insects.

Identification of Tree(s) and Description of Works

Reducing the height of 7 leylandii trunks that are currently in the range of 6-8 feet high and are essentially bare to ground level. These trees were previously topped to a height of 15 feet.

Replacements would be native species such as hazel, rowan, crabapple, elder

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
