Beech tree (T2) – Crown lift to 4 meters, reduce the canopy of the tree back from the property by 2 meters and to reduce the canopy of the tree by 15-20. Canopy is overhanging garage roof.

  - adding other relevant features on the site (e.g. greenhouse, paths)
