T2 Holly- Reduce height by 3 meters to allow more light into property and be maintained as a shrub

T4 Holly- Reduce height by 2 meters allow more light into property and be maintained as a shrub

T5 multi stem sycamore, remove selected branches marked in photo to reduce tree back from property
