Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Crown reduction of three Yew trees and three Yew bushes. The trees 1,2 and 3 are approximately 7m high and I'd like to reduce the crown by about 2m and prune back by about 1.5 m to encourage them to thicken up. The bushes 1,2 and 3 are part of a hedge planted twenty seven years ago. They are rapidly turning into small trees, and I'd like to return them to a hedge. They are approximately 5m high and I'd like to reduce to about 3m in height to allow more light back into the garden. Please see plan for location of trees and bushes.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
