Identification of Tree(s) and Description of Works

T1 Horse Chestnut - fell. This tree is in poor condition, has a bleeding canker and basal decay with possible signs of Armillaria (Honey Fungus). The tree poses a very high risk of failure.

T2 Corsican Pine - fell. This tree has previously suffered from storm damage and is left with only a partial crown, which is heavily weighted to one side. The tree is also ivy clad, adding further weight to the main stem.

T3 Beech - fell. This tree has basal decay and canker with a deep cavity at the base.

All trees are sited within the zone of influence and pose high risk to persons, property and vehicles.

Replant with Rowan, Weeping Birch and Tibetan Cherry.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
