Details of the pre-application advice received

The property is not on designated land, but the dormer is not permitted development because of the approval for an additional storey being granted on the original bungalow (Ref: 3/22/1741/ASDPN).

Any proposals should comply with East Herts District Plan 2018 Policies HOU11 and DES4.

Rob suggested that a FRA may be required, as the existing property is within Flood Risk Zone 2, due to the proximity of the River Beane. However, in actual fact there is no flood risk, as the ground floor finished floor level of the dwelling is 1.5m above the existing driveway, which then slopes down to the highway.

The applicant feels that although no adjacent properties have constructed a rear dormer under permitted development guidelines, there is no reason why there won't be in the future, and this would be deemed as acceptable development by the East Herts District Plan. Therefore the applicant is looking to gain permission for an equivalent dormer.
