The Change has a large garden with a wide variety of trees, most not visible to the public. Many were planted in the 1950's and are now coming to the end of their natural life. Advice has been taken from tree surgeons. The proposed works are to take out some of the trees that are posing a threat of falling branches or of toppling completely. The aim is to replace with smaller varieties of trees or shrubs in due course.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
