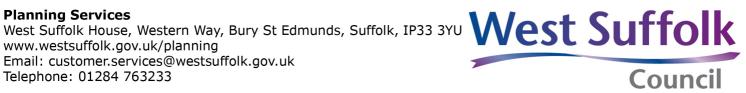

Sketch plan requirements Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries.
