T1 Ash - Pollard/ reduction of 4-5m and smaller basal stems removed. Due to excess dead wood in the crown which could be caused by small decay pocket starting to form at the base of the tree by previous bad pruning cuts of damage, also to reduce the weight of the tree due to decay pocket forming.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
