Maple Tree situated 50M to the West off the North West Corner of the main building of RVYC Yacht Club. The Land is rented from the main owner who has given full permission for this work to be done.

Field Maple to have a side crown raise 7-8M on the north side to allow boats to pass underneath on a grass hard standing (already installed). Doing only half a crown raise that is needed will minimise any aesthetics from most angles and stop the tree from being in the way with the current land use.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
