Details of the pre-application advice received

Quoted from letter dated 21/10/22 Jennifer Wallis:

'Located on the western roof slope of the dwelling the rooflights would not be overly prominent or visible from the public realm. As such, subject to the size of the openings respecting the character of the existing dwelling, I have no real concerns over the impact of the proposed velux windows on the character and appearance of the property or surrounding area.'

'Due to the location and nature of the openings proposed it would appear that the proposal could be accommodated without having any undue harm to the residential amenity of neighbouring properties. However, I would advise that the velux windows are set at a height above 1.7m so as to prevent any direct overlooking of the properties garden to the west.' QUERY: Height of proposed windows with regard to building regulations is 1.1m!
