



Flood Risk & Surface Water Assessment - Summary

As provided by the UK Government (https://check-long-term-flood-risk.service.gov.uk/risk), the property has a 'very low risk' of flooding by rivers, as demonstrated by the Environment Agency 'Flood Map for Planning' opposite, which shows the entire property, including its outbuildings and gardens designated as occurring in a 'Flood Zone 1' area.

Enclosures 13.3 and 13.4 show that the property itself is in a highly elevated position with regards to the River Font. The river bank, an embankment that runs the entire length of the River, South and Garden Fronts of the property, together with a haha to the southeast of the property, which separates the formal garden from the playing field to the southeast, all form significant barriers to any potential substantial increase in the river level of the River Font, which is highly unlikely based on past and future predicted levels. As predicted by the Environmental Agency, any significant and substantial rise in river level would be confined to the river banks.

As depicted by the UK Government Environment Agency 'Flood Map for Planning' (shown above), the property, Nunnykirk Hall and outbuildings, and all the surrounding gardens, are in Flood Zone 1. Flood Zone 3, as depicted in the above map is confined to a thin strip generally a couple of metres wide along the river bank boundary of the property.

As indicated by the UK Government (https://check-long-term-flood-risk.service.gov.uk/risk), the property is regarded as having a 'high risk' for surface water flooding; however, as highlighted through this risk assessment, this is unlikely to be reliable for a local area and very unlikely to be reliable for identifying individual properties at risk. During the initial build of the property, some three (300) years ago, an extensive, and very impressive drainage system was incorporated around the entire property to deal with any significant surface water flooding. It is believed that dwellings have occupied this site since Saxon times, and there is no documented evidence of any flooding whatsoever from either the river or surface water runoff to present times; and as presented here, this is very unlikely to happen in the future.




