T1: Elderberry. In first instance, remove branches overhanging garden of 3 Hall Cottages, The Street. Subsequently remove tree to allow parking area at 3 Victoria Cottages to be reshaped.
T2: Holly. Remove side trunk and branches overhanging garden of 3 Hall Cottages, The Street. Possible removal of tree if fencing realignment and bank stabilisation is required when parking area reshaped.
