Currently there is permission for B1 and B2 use for buildings 1 to 8 , depot (building 10) and storage and mixing of building materials , stationing of portable office (inside building 10). I am applying for permission to change the site plan line as buildings numbered 6 and 8 were demolished , and building 9 was dismantled, all occurring some years before i purchased the site.

I have replaced building 7 with a new building , and also i have replaced building 9 with a smaller building than the original, for which both have been granted planning permission.

I have included a new plan to show the amended site plan line , and to show the buildings as they are now. As buildings 6 and 8 are no longer there, i would like to include buildings 9 and 12 to have B1 and B2 use instead, and to add building 11 within the new site plan line (this is used for my own personal use at present). I am also seeking permission for the land to the rear of unit 12 to be included in the new site plan line if it is not currently.
