- G2 Trimming of stray Leylandii branch by 1m

- G4 Reducing in height by 0.5m Silver Birch x 3
- G5 Reducing height and trimming of Greengage/ Prunus by 0.5m
- G6 Trimming of Cypress x 2 by 0.5m

G1 is the only tree not within my property, but in the grounds of the Schoolhouse, School Lane. If approval is given I will discuss with my neighbour before proceeding with this tree and also offer back any trimmed branches.
