Due to the 2019 and 2022 droughts, our Ornamental Cherry - "Prunus Serrulata Autumn Glory" is now completely dead. This tree is within the Widdington Conservation area and is not subject to a TPO. Permission is requested to remove.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
