T1: Small beech tree. Dismantle and remove to ground level. This tree is in poor overall condition, with a split stem and an major included union on main stem. Tree has some old bracing present between 2 main stems. Tree grows in the shadow of mature beech tree so has little chance of thriving.

T2: Large beech tree. Tree has majority of growth on one side. Proposal is to prune back the heavy growth side by 2-3m and slightly thin (10%) to remove the overhang and weight and improve overall shape. Natural bracing will be left. Deadwood to be removed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
