Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Fell Leaning yew to ground level. T1 constitutes to a group of 3 yew trees which are now growing close to each other, T1 leans towards an access road. I believe that the other 2 yews (T2 being a particularly well formed specimen) in the group would benefit greatly by removing T1 to allow more space, and more availability of water and nutrients which will aid there future development and help to improve their longevity.

T2 + T3 - YEWS - Crown reduce by 2.5m in height and match in sides (radial spread reduction of approx 1.5m) as a repeat exercise of past managment reduction work. The crowns should be kept at reasonable size due to proximity of buildings. Prune epicormic growth from main trunks to approx. 4m in height above ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
