Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
T1 - Blue Gum Tree (Eucalyptus globulus) Large specimen rooted in boundary gardens between Fair Close and Bell Hill. Tree has a significant lean towards the South East with heavy branching on South Eastern aspect. There are some signs of defoliation in the upper crown - suspected cause is drought stress from compaction and unbalanced root-plate loading.
Remove, to primary union, single lowest large limb that extends SE. This will significantly alleviate pressure on the North West buttresses.
Remove all deadwood from upper-crown greater than 25mm in diameter.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
