Reduce and reshape 5 x Sycamore by approx 3-4m all round (Marked T1 -T5 on plan) and reduce and reshape 1 x Cherry (marked T6 on plan) by approx 2-3m (this tree is a lot smaller than the others) all round to maintain the trees, cut back from overhanging the neighbours garden as they are getting rather large.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
