(T2) Leylandii – Please advise how much you would like to reduce the overhang branch by and finishing length in metres.

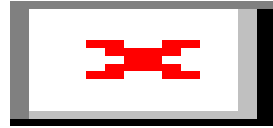
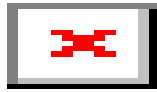
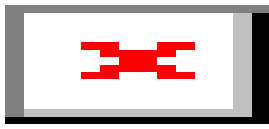
(T3) Holly – Please provide the finishing length of the branch in metres after 4m approx has been removed.
