Description of Proposed Works

Please describe the proposed works

We are proposing two sets of work:

1. Externally insulating the entire property (due to no cavity wall or existing insulation) and cladding over in timber (ceder). In order to do this we will need to pin insulation which will then be clad over to form a rain screen.
2. Installing an ASHP to the front of the property, to omit the existing gas boiler. Due to the layout of the existing driveway, the location of existing services within the property and the manufactures recommendations on its position and surrounding space, the ideal location of the ASHP is to the front of the property. It should be noted that this location is not easily viable from the road due to the existing fence and planting. Additionally, as shown on the proposed plans we intend to enclose the existing front door and relocate it to the side of the building, changing the way the building is approached, therefore making the proposed location the most discreet.

Ceder cladding, installed vertically with open joints. Planks to vary between 3 different sizes in a random pattern. It is intended that the ceder will silver over time to compliment the existing concrete roof tiles.
