G2 - GROUP OF OAKS - 3 OAKS TO PRUNE BACK BY APPROX 2.5m TO REDUCE END WEIGHTS OVER GAS TANK AND CHILDRENS CLIMBING FURNITURE (GROUND FIXED). KEEP FLOWING LINES, BACK TO SECONDARY GROWTH POINTS - ALL TREES IN GOOD HEALTH. PICTURES ATTACHED TO EMAIL.


