The oil storage tank has been disconnected and emptied for the duration of the works and is considered unfit for reinstallation. The oil storage tank will therefore require replacement on completion of the remedial works. Listed building consent was granted to proceed with the remedial excavation works and Braintree District Council have confirmed consent isn't required for the new tank, but planning permission is.
