Replacing of existing roof. Due to the clay pan tiles showing signs of deterioration (age/ weather) as well as the roofing felt and batons are rotten in several places.

Work will include complete stripping of all roofing tiles, roofing batons and the black mineral felt. The removal of the cement valleys, ridge tiles and cement foundations, the dormer windows to have the cement verge removed as well as verge boards.

We believe the current roof to be over 80 years old and thus have exceeded its lifespan.

The new roof tiles will comprise of either 'Sandtoft old English' or 'Sandtoft Victorian' both clay pan tiles (choice will be based on availability at time of work carried out).
