These trees are very close to the flats and work open up the area by the flats.

T5 Sycamore - reduce all round by 2.5 meters.
Again the tree is close to the flats, the work is to open up the area by the flats.

T6 Sycamore + Field maple reduce back from road by 2 meters.
The trees are encroaching onto the road.

T7 Oak, ~~Sycamore~~ These trees are going towards the house and blocking a street light. To prune back the trees by 2 meters.
T8 Sycamore

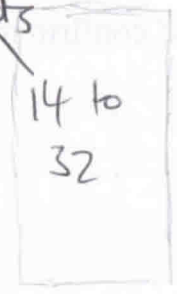

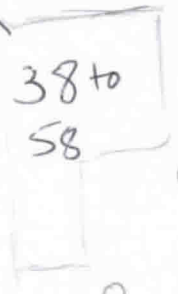
