3 x Horse Chestnuts overeaching garden and road, blocking light to property. Reduce by 2- 3metres and reshape, standing height to be approx 11-13 metres when completed.
2 x Yew. Reduce by 1 - 2 from 6-7 metres down to 5-6 metres and reshape.
