### Conclusion

In view of the above it is clear that the decision-making process for the determination of any application is therefore to assess whether the adverse impacts of granting planning permission for the proposed development would significantly and demonstrably outweigh the benefits or whether there are specific policies in the framework that protect areas or assets of particular importance which provide a clear reason for refusing the development proposed. Whilst the proposed buildings are not considered worthy of retention or conversion and there is insufficient information to advise whether the dwelling would comply with the neighbourhood plan, in this instance given the tilted balance is engaged, officers do not consider that there are any significant or demonstrable harms that outweigh the minimal benefit of one additional dwelling in a relatively sustainable location in terms of the principle of development.
