Based on the above assessment, should a full application be made, the proposal for the conversion of the barn to a holiday let is likely to be considered acceptable in principle, having regard to local plan policy RT17 and H9. A Class Q prior approval application can also be applied for, subject to the criteria being met.

There is likely to be negligible impact to residential amenity due to the closest neighbouring property being the applicant's property and it is also a reasonable distance away for the impact to be minimal. It is also considered that the conversion causes no adverse impact on their landscape setting, wildlife habitats, nearby residential amenity or highway safety.

If a full application were to be submitted, it is likely that a condition would be put in place to ensure that the holiday let is to remain as a holiday let and not become a new dwelling in its own right, in the countryside
