Introduction

The application proposes an external swimming pool to an existing grade II listed farmhouse dwelling on Street Farm. A previous planning application has been granted for a single story extension connected to the north wing of the main dwelling (REF: DC/22/00138). This proposal locates the pool directly north of the extension adjacent to the existing sunken terrace of the extension. A low brick wall is proposed to form an enclosure for the pool.

The applicants also own a Cafe and secondary ancillary buildings which are within the site and located west of the dwelling.

It is assumed that you (the customer) own the land on which the pool is to be constructed and that you will obtain any planning permission, building regulations approval, listed building consent or any other permissions and consents that may be required.

No responsibility undertaken for damage during access or for reinstatement around the pool or the approach. It is assumed you will clear the site of all existing shrubs, trees etc.

UNDERGROUND WATER

If there is a possibility of the ground water level rising to within 300mm of the finished paving level at any time of year this could cause the pool to lift, therefore consideration must be given to providing permanent land drainage from immediately beside the pool to a ditch or drain **at extra cost**.

UNKNOWN FACTORS

Should underground cables, pipes etc., be encountered and require diverting or repairing this would be charged extra, as would underground water or unstable sub-soil and any additional drainage.




